Points – you can make gifts using your credit card to earn reward points.

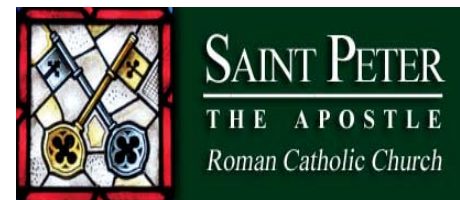

How to Enroll:

Start giving electronically and help yourself **AND** your parish!

To get started, you will need either your bank routing and account numbers **OR** your credit card number—where you want your electronic gifts to come from.

Then choose 1 of the following 3 ways to enroll:



ONLINE (the fastest and easiest way to enroll) – log onto Parishpay.com, click on “HELP ME CONTRIBUTE”, and follow the step-by-step instructions.



PHONE – call 866-PARISH1 (727-4741) and speak with a support specialist who can help you enroll.



ENROLLMENT CARD – pick up an enrollment card at your parish, fill it out completely, and return it to your parish office or drop it in the collection basket.

Is there any cost to enroll in ParishPay?

There is **NO** cost to you to participate in the program.

Is the program safe?

Our site uses SSL (Secure Sockets Layer) 128-bit encryption technology to ensure that all personal and sensitive data - credit card number, email address, name, address, etc. - is transmitted safely and securely every time.

When can I make my regular gift?

You have the choice of making your regular contribution on the 5th or the 20th of the month or split it between both dates – whichever is convenient for you!

What happens if I feel uncomfortable not having something to physically drop into the collection basket?

Special gift slips are available for you after you're enrolled which you can drop into the collection basket during Mass.

Can I contribute to second collections including both parish and diocesan collections?

Yes, you have the opportunity to contribute to second and special collections via ParishPay, including for Christmas, Easter, Peter's Pence, etc.

How can I change my information, such as the amount of my gift, my credit card number or mailing address?

You can provide these changes to the church office or directly by going online to parishpay.com or by calling 1-866-PARISH-1 (727-4741).

Which payment methods are accepted?

You can have gifts automatically debited from your checking or savings account or charged from your American Express, Visa, MasterCard, or Discover.

Can I receive receipts for tax purposes?

Yes, you can print out an annual receipt directly from the website every January, which you can use for IRS documentation.
